

# Walk For Abolition: End the Death Penalty

Stan was the co-founder of the Los Angeles Crips gang. In 1981 he was convicted for the the murder of Albert Owens, Thsai-Shai, Yen-I-Yang, Yee Chen Lin. Stan deeply regrets his gang involvement and has always maintained his innocence of these crimes. While on death row, Stan has written 9 children's books that educate them in how to avoid gangs. He also worked to end gang violence through his "Tookie Protocol for Peace:A Local Street Peace Initiative". His work has resulted in multiple nominations for the Nobel Peace and Literature Prizes. This summer he was recognized by the President of the United States when he received a presidential award for his volunteer work to help youth.

Monday, 12th December, 2005.

We have walked since the  
1960's every time the State of  
California has scheduled an  
execution.

You can either participate in  
the whole 'Walk' or you can join  
it at rallying points on the way.

We want you to make a  
difference on this day. We want  
you to join us and be seen to  
demonstrate that the State of  
California must not carry out  
this execution.

We do not want the State of  
California to kill in our names.  
The death penalty is wrong and  
we can live without it. The State  
of California can protect itself  
without having to kill. Tell  
Governor Schwarzenegger to  
stop this execution.

### Join With Us! Walk For Abolition : End The Death Penalty

If by the 12th of December the 9th Circuit Court of Appeals fails to prevent this execution from going ahead or if the governor does not grant clemency, it is up to **us** to show up, be seen, be heard and walk together. It is up to **us** to be a visible presence in our community to say that this execution does not have to be carried out. It is time. The State of California does not have to execute Stan 'Tookie' Williams to protect itself. The State has the option of Life Without the Possibility of Parole. We do not have to kill. Please see details of the walk overleaf and decide to make the difference to stop the killing.

The Walk For Abolition welcomes anyone who opposes the execution to join in this public witness. If you are unable to do the whole walk, there are rallying points on the way. You can join us for a portion of the walk and/or demonstrate with us and show your support by meeting us at the rallying points.

The Walk for Abolition will meet with Mill Valley Seniors for Peace for a demonstration at noon in Mill Valley. Join Us.

The 25 Mile Walk For Abolition begins promptly at 7 am rain or shine at the Palace of the Legion of Honor, in Lincoln Park, 100 -34th Avenue, San Francisco, 94122. We walk peacefully as a large group over the Golden Gate Bridge, proceed through Sausalito, Mill Valley, Larkspur, Greenbrae, into San Rafael and end at the main east gate of San Quentin at 6 pm.

You can join the Walk at designated rallying points. Escort vehicles accompany the walk.

You will need comfortable shoes, warm layered colorful clothing, flashlight. Back pack with a change of socks, shoes,

extra clothing etc. We stop for refreshments. Escort cars carry back packs and walkers in need of rest.

8:55 am North end of the Golden Gate Bridge Car Park

Sausalito Lateral to Alexander Ave. to Bridgeway into Sausalito

10:40 am Sausalito - Head of Bay Trail leading to Mill Valley.

11:45 am The Redwoods, Camino Alto and Miller Avenue, Mill Valley, CA, 94941. Lunch and Demonstration with Mill Valley Seniors for Peace.

Continue Camino Alto Ave to Corte Madera Ave to Magnolia Ave to Bon Air.

2:30 pm St. Sebastian Church, 373 Bon Air Road, Greenbrae, CA, 94904. Rest stop. Bon Air to Sir Francis Drake to Wolfe Grade to D Street to 4th Street to Court Street.

3:15 pm St. Paul's Episcopal Church, 1123 Court Street, San Rafael, CA, 94901. Rest stop.
