**INFORMATION:**

On May 9, 2008, at 4:51 p.m., Santa Cruz Police Department officers responded to reports of several people smoking marijuana in the parking lot at W Cliff Dr and Columbia St. Officers contacted the group and requested identification. One suspect, later identified as Dawnna Deiss, ignored an officer's repeated request and walked away.

When the officer attempted to detain Ms. Deiss, she threw a cup of hot liquid onto his face. Despite being burned, the officer was able to control and eventually take Ms. Deiss into custody. Ms. Deiss was treated and released from Watsonville Community Hospital for injuries she sustained during the arrest.

In the course of this incident, another suspect, later identified as Linda Allen, attempted to conceal evidence by placing two glass marijuana pipes in a nearby trash can.

Ms. Deiss was arrested on charges of battery on a peace officer, resisting arrest, and possession of marijuana. Ms. Allen was arrested on charges of destroying evidence and possession of marijuana.
