5 Major Victories of the Case:

1. Former BART officer Johannes Mehserle was arrested for murder after community rebellions. He is the first cop to be charged with murder in California. His bail was set at \$3,000,000 and spent 3 weeks in Santa Rita Prison.
2. District Attorney Tom Orloff was pressured to resign after dragging his feet in charging/questioning the officers. Orloff was the same D.A. to try Huey Newton.
3. Police Chief Gee resigned after failing to properly discipline officers involved in Grant's murder.
4. Marysol Dominici was fired for her participation in brutalizing Grant and his friends.
5. Tony Pirone was fired for assaulting the young men on the platform and repeatedly using racial slurs.

Who was Oscar Grant? He was a loving and caring father of a young daughter and a hard working young man. He was murdered for attempting to make peace between his friends and BART officers.

The case against Mehserle is a case that puts pigs on warning. This is a piece of history. Manslaughter is not enough! We must organize to push for a murder conviction! Community support is necessary!

On January 7, 2009, the people of Oakland rose up in response to Grant's murder and the governments failure to charge his executioners. Over 100 people were arrested on false charges including Minister of Information JR and Holly Works.

Currently there are 4 civil lawsuits waiged against BART officials by Grant's family and his friends who were and continue to be brutalized, harrassed and terrorized.

It is time for justice! Justice for Amadou Diallo, BPP Deputy Chairman Fred Hampton, BPP Field Marshall George Jackson, Sean Bell, Deandre Brunston and Oscar Grant!
