Dear Dwaine:

AFSCME Local 3299 (hereinafter, "AFSCME" or "the Union") hereby serves NOTICE of its intention to engage in an unfair practice strike, as well as to engage in picketing activity, by members of the Service (SX) and Patient Care Technical (EX) bargaining units for a period of twenty-four (24) hours at all locations of the University of California (hereinafter, "University") that employ members of the SX and/or EX bargaining units. Limited exceptions regarding discrete areas in which AFSCME plans to limit its strike are listed below under "Non-Precedent-Setting Exceptions." This strike is called to protest the University's violations set forth in PERB Charge Number SF-CE-1033-H.

Unfair Practice Strike Location:

All facilities of the University of California that employ members of the Service (SX) and/or Patient Care Technical (EX) bargaining units.

Unfair Practice Strike Duration:

The strike and picketing shall commence with all shifts beginning on or after 12:00 AM on Wednesday, November 20, 2013 (in other words, all shifts beginning after 11:59 PM on Tuesday, November 19, 2013). Any employees who are in the midst of shifts at that time will continue working through the regular close time of their shifts and will not leave in mid-shift.

The strike will conclude with the commencement of all shifts that commence after 11:59 PM on Wednesday, November 20, 2013. Striking employees who were scheduled to work shifts commencing at or before 11:59 PM on Wednesday, November 20, 2013 will remain on strike through the close of those shifts and will not report to work in mid-shift.

Non-Precedent-Setting Exceptions:

On a non-precedent-setting basis, AFSCME hereby limits this strike in the following non-precedent-manner: AFSCME is not calling for a strike by the attached list of patient care technical staff, who will instead report to work at the shifts and areas shown therein. In addition, any strike activity will be called off immediately in any locality where there is any event causing a sharp upward spike in medical treatment needs.
