Dear President Yudof,

Upon your arrival at University of California more than seven months ago, I reached out to you on behalf of UC's 8,500 Service Workers, to convey to you the urgency of agreeing to a contract which lifts their families out of poverty.

When we met, Service Workers had already been bargaining for nine months. After our initial exchange at your welcoming reception, it took you a full six months to agree to meet with me. I appreciated that meeting, in which UC seemed to acknowledge that the needs of Service Workers, UC's lowest paid workers, were deep enough to merit a departure from past UC policy.

Since this meeting, however, several months have now passed without substantial movement which would lift our members out of poverty.

AFSCME has consistently expressed a willingness to meet in good faith, think out of the box, and engage with UC on the possibilities of settlement. We have now agreed to two sets of Mediators, most recently Art Pulaski, whom UC chose and who has since recommended a settlement to which UC has refused to respond.

We have now been in bargaining for nearly a year and a half.

During that time the Regents have approved raises and bonuses for highly paid executives totaling \$14.5 million. Just weeks ago, UC agreed to a contract with Patient Care Workers which UC costed at \$127 million. To Service Workers, UC's lowest paid workers, UC continues to say that you do not have the money. As our state-appointed fact finder stated last spring, this is a matter of priorities, rather than resources.

I have received your letter of January 19, alleging that our actions are not in "good faith". Let me assure you that we believe our actions to be fully lawful

Over the past year and one half, we have met with Regents and Chancellors multiple times, done hundreds of actions, instituted a speakers boycott, initiated the facing poverty atuc. or gwebsite, run television commercials, and launched a statewide five day strike, in order to redirect the University's attention and priorities away its hundreds of six figured executives, and onto the University of California's working poor.

Our sole intent is that you finally hear the voices of these 8,500 people and their families, recognize the urgency of our plight, and agree to a just contract. Our members and their children suffer *every day* that you do not make the decision to settle our contract.

We suffer by losing our homes, not sending our children to college, not buying our children holiday gifts, and never seeing our spouses or children because we must work three jobs to make ends meet. 96% of our (Your) UC Service workers are eligible for some form of public assistance. This is disrespectful, inappropriate, and unjust.

You have the power to end that disrespect today, by leading the University to act in a positive, quick manner to resolve our Service Workers Contract. Turge you to do so.
