Complainant alleges money came up missing from a locked box and he found the key to the box in his roommate's pants pocket. An argument ensued and she dialed 911. Officers came to his home and he was not given a chance to tell his side of the story to the officers that arrived on scene instead he was treated as the aggressor instead of his roommate. Complainant alleges one officer kept referring to him as "dude" and also asking him for a "PFN." The Complainant found this to be very offensive. Complainant also alleges the officers searched his apartment and took his weapons. Officers also failed to write a police report.

Rationale for administrative closure – Based on the Complainant's failure to cooperate with the investigation. Complainant did not leave an address on his complaint form. Complainant indicated he was homeless. Several telephone calls were made to the telephone number listed on the complaint form and messages were left but never returned.
