They are responsible to enforcing Section 610, which provides criminal penalties for such retaliation. Despite many documented complaints from workers about retaliation for protected union activity, the agency, which is responsible for such prosecutions, has failed to initiate any prosecution for 5 years or the entire time that the agency has had responsibility for enforcing this section of the labor code.

In addition they have refused to enforce proper reporting of the LM2's. In the case of LIUNA Local 166, numerous false statements have been included in their documents and have not been rectified. The agency also refuses to release a list of all the complaints under this statute for enforcement action.

Members of the Bricklayers and Hodcarriers will provide testimony about the failure of the Office Of Labor-Management Standards and it's director Jennifer Bergschneider and other staff to enforce the law equally.
