#### BACKGROUND:

During the 3-day negotiation to turn the 3 1/2 year vacant Wells Fargo-leased bank into a Community Center, Desiree was the media liaison at 75 River Street. She spoke with *Sentinel* reporters, *KSBW*'s Phil Gomez, *KION*, the *Patch*, *Good Times*, the *San Jose Mercury News*, and *Free Radio*.

She helped negotiate a peaceful resolution of the occupation at which there were no arrests. Two months later, she was arrested without warning at her home and taken to the jail in handcuffs.

Despondent, Desiree attempted suicide and wound up in Dominican Hospital.

Desiree is the primary caretaker for her mother, who is suffering from cancer and going through chemotherapy. Desiree is 19 years old.

Desiree's family is very financially strapped. She recently got a job locally but wonders how she's going to get to work, take care of her mom, and keep up with the long legal battle that requires many court appearances, fund-raisers, and other events.

Desiree has shown herself to be a brave, concerned, and involved young woman. She exemplifies how we would like our young people to act.

It is therefore an outrage that her sincere efforts to aid the public's understanding of a peaceful action should be rewarded with felony and misdemeanor charges!
