Who really rules in Russia?

The murder recently of a crusading anti-mafia Russian parliamentary deputy underscores fears that the primary threat to that country's nascent democracy comes from mushrooming organized crime. Administration policymakers, meanwhile, find they must play a game of catch-up on a security threat potentially far more damaging to vital U.S. interest than the infamous Ames spy affair. ...

In 1991, my former boss, then-Senator Alan Cranston, sponsored comprehensive legislation to put administration of justice help, including policy training, at the forefront of U.S. democracy-building assistance to Eastern Europe and the emerging republics of the former Soviet Union.

The Cranston initiative counted on bipartisan Senate support and was unique in two respects: California's senior senator vigorously opposed U.S. police training programs 20 years earlier when the Cold-War cast of training offered by the Agency for International Development's Office of Public Safety provoked several human right scandals. And Mr. Cranston had forged a working relationship on the issue with the Justice Department of then-Attorney General Richard Thornburgh, another strong advocate of paying more attention to international crime.

Mr. Thornburgh, however, resigned in mid-1991 to run for the U.S. Senate seat now held by Democrat Harris Wofford. Mr. Thornburgh's successor, William Barr, evidenced little interest in international law enforcement and administration of justice development.

Martin Edwin Andersen, the first national security whistleblower to be given the U.S. Office of Special Counsel's "Public Servant Award," will also participate in the news conference. Andersen has written that Snowden is not a legitimate whistleblower and that he illegally "leaked massive amounts of national security information" and then fled to Russia, a police state where "real whistleblowers and investigative journalists alike are under continuous threat." Andersen has worked as an assistant professor of national security affairs at the National Defense University and a lecturer at the U.S. Naval Academy.

Martin Edwin Andersen (@InsightCaptain) is a former senior adviser for policy planning at the Criminal Division of the U.S. Department of Justice (DoJ) and senior adviser for defense and foreign policy for a Senate Majority Whip. More recently, he has served as a professor of history and national security at the National Defense University (NDU) and the U.S. Naval Academy.

The winner of the 2001 U.S. Office of Special Counsel's "Public Servant Award," Andersen was its first national security whistleblower recipient. He received the recognition for fighting against U.S. Department of Justice failures to protect CIA classified information, senior Criminal Division management leaving itself open to blackmail in proto-Putin Russia, and myriad issues of financial

mismanagement, visa fraud, employee pre-selection and favoritism, and the abuse of travel rules and regulations.

In his most recent case involving U.S. Southern Command and the NDU, Andersen filed three Congressional Disclosures to the Intelligence Community Office of the Inspector General (IC OIG), the latest of which was forwarded by the Director of National Intelligence to the House and Senate Intelligence Committees in June 2018. The non-classified part of the scandal included crimes against humanity cases involving the conviction in civilian court of an NDU / Southern Command partner, the criminal prosecution of an NDU Title X employee who had previously belonged to a state terrorist organization, and the outing of a third, whose former organization claimed responsibility for the murder of a U.S. diplomat.

The author of three books, one written in Spanish, he has penned numerous scholarly articles on human rights, the rule of law, indigenous peoples, policing, homeland security, civil rights, maritime security, Latin America, war crimes, and civil-military relations. While teaching at NDU he was the editor of a path-breaking academic peer-reviewed journal published in three languages.

As an investigative reporter, Andersen's hard-hitting stories have resulted in investigations by Offices of Inspectors General and the FBI. As later recognized in a Miami Herald editorial, he issued a prescient public warning on lax U.S. and

Argentine government attitudes about possible terrorist attacks, which then occurred with 85 innocent people murdered in the AMIA Jewish community center bombing in Buenos Aires.

A former president of the Midwest Association for Latin American Studies (MALAS), Andersen has worked in Africa, Europe, and Latin America, always earning "Outstanding" performance reviews.



- You may have heard that Mick stopped by CHDS last Thursday afternoon. I understand that during his short visit he made some comments that may have made some uncomfortable. I want to assure you that we take employee workplace safety very seriously and in response to the comments he made, in consultation with the NDU President and Office of General Counsel, I have prohibited him from the CHDS spaces. The NDU lawyer has communicated this bar to Mick so he is aware. Accordingly, if you should be approached by Mick or see in CHDS spaces, you should inform a member of CHDS management who in turn will contact NDU Security to have him escorted from the premises.
- I also understand some of you may have gotten phone calls from Mick, and I want to ensure that you know that if you wish to talk to Mick, there is no problem doing so. I, Denise Alvarez, felt frightened and concerned for my safety upon realizing and then seeing Mick Andersen in Alicia Torres and Monica Stapleton's office on Thursday, June 16, 2011. My feelings of concern were mainly due to Mick's recent irrational behavior and his disheveled appearance. However, it is also partially due to the unexpectedness of his visit. I understood that he had been temporarily barred from NDU. Therefore, it was a surprise to see him at CHDS.

I write to inform you of an unfortunate personnel situation at the Center for Hemispheric Defense Studies (CHDS) that has the potential to negatively impact CHDS and the National Defense University.

Since Friday, 27 May 11, our Chief of Publications, Mr. Martin "Mick" Andersen has been sending out a series of derogatory emails with a wide distribution that includes Admiral Winnefeld, Commander, US Northern Command, the Chief of Staff of US Southern Command, former Secretary of Defense William Perry, ASD Stockton and DASD Mora as well as CHDS alumni groups in Latin America and other private civilians.

I believe that Mick is sending out these emails as retaliation after concluding that he might not be offered an extension on his current, one-year Title X contract that expires at the end of this calendar year. A few days ago I learned that Mr. Andersen had warned the CHDS Human Resources Chief last summer that he would retaliate if CHDS did not renew his contract.

I do not know, but perhaps a contributing factor to Mick's unusual behavior is the fact that he was in a car accident on 14 May, after which his doctors discovered a lemon-sized tumor on his brain. He is currently on leave following a 3 June operation to remove the tumor which we are told was benign and fully removed. We understand that his prognosis for a full recovery is exceptional.

Despite their sensational subject lines (such as "Crisis in Ethics at CHDS"), these emails mostly deal with his personal grievances toward a dozen or so people related to CHDS that he clearly felt had slighted him in some way; others focus on decisions I made—with which he obviously did not agree, while still others involved what most people would consider innocent office banter. As you might expect, in each case (many of which are five or more years old) he leaves out details that would provide context, while relating only one side of the story. I am confident that the decisions made by me and others in the issues he raises will stand up to scrutiny by any objective observer as having been made in the best interests of CHDS, National Defense University (NDU) and the Office of the Secretary of Defense (OSD). However, we are reviewing each of the issues raised in his messages to further ensure that appropriate action has been taken in all cases.

With the concurrence and authorization of NDU President VADM Rondeau, his IT account at NDU has been closed and emails from his personal email accounts have been blocked to ndu.edu addresses. All further contact with him is being managed through the NDU General Counsel. Mr. Andersen's supervisor has also sent him notice via registered mail to cease emails to outside entities. Nevertheless, he continues to send emails from his personal account to the many addresses to which he has access.

Mr. Andersen will continue to convalesce from his surgery over the next several weeks. We do not plan to grant him access to CHDS for the time being. We will further address how to manage his future performance of his duties, in close consultation with VADM Rondeau, the NDU General Counsel and the Chief of the university's Human Resources Division

As he was previously the CHDS strategic communicator, he has a broad list of governmental and non-governmental contacts, which he has used extensively in his

mailings. These defamatory and misleading emails have the potential to create a negative perception; however, after receiving multiple e-mails and considering their content, many recipients have indicated that they understand that the messages lack objectivity. Nevertheless, I am concerned about the rights and reputations of CHDS personnel who have been defamed by his emails, as well as the impact on the image of this Center and NDU. I will keep you informed as this unfortunate situation proceeds. Please let me know if you have any questions or concerns.

This week serious moral and ethical problems emerged at CHDS. They are:

- The wife of a senior member of the Academic team sent an e-mail, which I saw, to a CHDS colleague in which a picture of First Lady Michelle Obama was placed side-by-side a chimpanzee in a racist parody. Although I encouraged the person to send the e-mail to the front office, so as to make an official electronic record, he said he would not, saying such an action would not result in any action being taken anyway.
- 2) A failed job applicant visited CHDS to complain that the faculty team chosing applicants was stacked against him. An important part of this story apparently evolves around accusations--seemingly well-founded--that one of the faculty judging his application was prejudiced against him because personal tensions arising from this faculty member being intimately involved with a wife of a friend from this person's country. A complicating factor is that the applicant is married to a well-known member of the U.S. Senate staff.
- 3) A former director of CHDS has said it is understood that Downie will be leaving CHDS soon and that Craig Deare plans to replace him. Deare lost his security clearance due to unethical conduct in the U.S. Senate as a one-year fellow, and later cheated on his wife by having an intimate relationship with a CHDS contractor whom he was supervising. Despite this, Downie renewed Deare's contract for three years.
- 4) A new faculty member with extensive political contacts around official Washington has been the subject of harassment by a senior faculty member, who she says has even followed her around the office to check up on what she is doing. (I personally witnessed one instance of this.) This senior faculty member was given the position without having a Ph.D, a factor which is used against other faculty and



I write this letter of support for Martin Edwin 'Mick' Andersen, who was my supervisor during my internship at the Center for Hemispheric Defense Studies (CHDS) at the National Defense University. My internship was from August- December 2010. My background in indigenous studies focusing on Latin America matched me with Mick as my supervisor, who at the time was the leading expert on indigenous politics in Latin America. Under his supervision, I learned a great deal on politics, international relations and how indigenous identities are constructed and deconstructed during coups, warfare, and within resistance movements. Unfortunately, the working environment at CHDS did not match my learning experience. I immediately observed poor management and passive-aggressive communication among the faculty, especially towards Mick. Several comments made to me via sarcasm and hostility suggested he was a type of annoyance for advocating for indigenous human rights. My experience at CHDS proved difficult because of the indirect comments always communicated about Mick. I decided to maintain space and distance with these professors so as to not engage with disputes that did not involve me.

The overall working environment felt difficult for many reasons. It was obvious that men dominated the space and although unfortunately expected, I sure did not expect such vocal sexist slurs towards women who were participating as students from different Latin American countries. On various occasions, I heard two professors speaking among themselves ridiculing a female student for suggesting a solution to proposed problem, the joke being her solution was absurd because she was a woman and 'clearly' did not understand the military politics ruled by men. The most uncomfortable comments were those communicated to me about different professors who were ex-high ranking military officials responsible for many murders during the coups in Chile and Honduras. There were always conversations about not challenging these individuals because they carried a lot of power at CHDS. In my five months there, I was able to observe a culture of corruption, silence and generic sense of paranoia and "walking on eggshells." I worked hard to not engage with this environment as it was unhealthy, toxic and a disappointment. I was fortunate enough to meet Mick, someone who shared strong work ethics and obviously had a common interest in advocating for indigenous human rights. As mentioned, Mick has an impeccable work ethic and he values his intellect and integrity, which explains the clash CHDS had with him. For this reason, I write this short letter as a testimony to what I observed and experienced with CHDS as well as what I can attest to working under Mick's supervision. I hope this investigation moves forward.



Nevertheless, the U.S. Congress continues to allocate more than \$100 million in annual counternarcotics security assistance, training, and Mexican purchases of U.S. military equipment to prosecute the so-called war on drugs with no signs of abating. Over this time, homicides in Mexico—many of them cartel-related—have quadrupled.

Albeit dramatic, the Cienfuegos case is just one example of dysfunctional U.S security cooperation arrangements with foreign governments. This is an issue the U.S. Congress has the power to address. In fact, there is already a mechanism for blocking U.S. security assistance to bad actors: the Leahy Law. First introduced by U.S. Sen. Patrick Leahy in 1997, the provisions that made it up were informed by the brutal counterinsurgencies in Central America in the 1980s, in which military units financed and trained by the United States carried out atrocities such as the 1981 El Mozote massacre. It bars the United States from providing security assistance to foreign military or police forces that have committed documented gross human rights violations.

Failing to specifically address military and police corruption leaves a major blind spot in efforts to bolster good governance throughout Latin America.

WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:



I received an email message this morning around 10.20AM to meet with Col.Bell, Michael at 11:00AM. He is the Chancellor of the College of International Security Affairs (CISA) of National Defense University (NDU) where I am employed as an Associate Professor, I was very nervous because during my previous meeting with him on 18 March 2011, he started almost immediately to scream and shout at me about my supposedly inappropriate use of economic reasoning when teaching the Strategic Thought class. So I called my colleague Dr. Tom Blau for advice, and possibly serve as a witness. He laughed saying, his presence would really generate some abusive language. So headvised me instead to seek the advice of Bob Sharp, a previous member of CISA's faculty who still works at NDU. He advised me to be as calm as possible, avoid any confrontation, and take notes of everything Col. Bell says for future reference. Should there be any verbal abuse, he advised meto simply say the meeting is over and walk out. At 11:00AM, I arrived at Col. Bell's office where Herman "Skeets" Meyer, the Dean of Students of CISA was waiting for me. He then asked Lindsey, Co., Bell's secretary, to see if he was ready for us. She went in and came out saying to go in. As Mr. Moyer and I proceeded to walk in, we were joined by Dr. Craig Decre the Dean of Administration of CISA. Mr. Meyer and Dr. Decre then positioned themselves near the closed door inside Col. Rell's office, while I approached him. Col. Bell was sitting at his desk. When I ask where I should sit, he told me to stay standing in front of his desk. He proceeded to sny that my complaints about having my acutemic freedom vidated are completely unfounded. The problem is that I refused to teach according to the syllabus of the "Strategic Thought" core classifuring the previous Spring Semester. 1then said that I need to sit down to write down exactly what he was saying, in accordance to Bob Sharp's advice. As I was writing he also said that he had given me two options in response to my desire to not follow the syllabus of the Strategic Thought class. Tremember him saying that one option waste develop and teach a completely different class. As I continued to write down these statements, he then told me that I'm being placed on administrative leave. Unfortunately, I was still trying to writing down his previous sentence. Then he said, "Do you understand me?" Theid my band up to signal that I was still trying to finish writing. Then best: dienly screamed, "Answer me when I speak to you!" That is when I stood up and said that I am not going to telerate his abusive language and improfessional conduct again, and that this meeting is over. I proceeded to walk to the door. Again, this was in accordance with Bob Sharp's advice. Unforuntately, Mr. Meyer and Dr. Deere told me that I'm not going anywhere and that the meeting is notover. I said again, I'm not going to tolerate such unprofessional conduct and reached for the door handle. That is when but Mr. Meyer and Dr. Deere grabbed my arms and shoulders and forcefully pulled me back, yelling now that I'm not leaving this office. That was when Col. Bell approached, saying something else about being place on administrative leave, while I was struggling to break free d Mr. Meyer's and Dr. Decre's grasp.] finally managed to open the door and exit, where a group of security officials and armed MP's were waiting for me. I was immediately told to surrender my CAC card, office key, and ID hadge. After I complied, the entire group, including Dr. Deere and Mr. Meyer escurted me to my office where we proceeded to pack up my office. Col. Bell said something due to me, but I answered that his unprofessional conduct is completely unacceptable and that there will be consequences. After working for almost a full hour, I was exerted by the MPs to the courtyard outside of Lincoln Hall. That is when I thanked them for the professional conduct, shook their hands, and bid them fairwell.

Finally, in an email I sent on December 20, 2016 to Mr. Glenn Fine, the DoD IG, with a copy to the ICIG HOTLINE team, I noted that my protected disclosures have received a disconcerting amount of attention from unknown person(s) in Vladimir Putin's Russia. As I mentioned then to Mr. Fine, this was unfortunate indeed, "as Mr. Putin has scored some unfortunate public relations victories in recent weeks and months and SouthCom's failure to do what is right may in fact be setting the United States up for another international black eye when it comes to questions of the rule of law."
